- 1) All vehicles parked in the designated student parking areas are required to have a current parking decal clearly affixed on the rear window in the lower left corner and a hang tag displayed and hanging from the rear-view mirror. Each car driven must be registered separately and have its own parking decal and hang tag. Temporary parking decals may be purchased for an additional \$5.00 fee. A vehicle without the proper parking decal and hangtag displayed will be towed at the owner's expense.
- 2) All vehicles on the campus of North Augusta High School are subject to being searched at the discretion of the administration.
- 3) A student may not sell, transfer, or loan his/her decal to anyone. Any decal used in violation of these rules will be revoked and the parking fee forfeited.
- 4) Students parking in the assigned lot (designated on the parking tag) will park on a "first come, first served" basis. There will be no reserved spaces.
- 5) North Augusta High School assumes no responsibility for accidents, thefts, or damage to vehicles parked on campus. Vehicles should be locked at all times.
- 6) The maximum campus speed limit is 10 mph. Violators are subject to suspension and having their parking privileges suspended/revoked.
- 7) Drivers must yield right-of-way to buses and pedestrians at all times.
- 8) Students are not to return to their vehicles until the end of the school day. Students needing to return to their vehicles must have written permission from their administrator.
- 9) Any discipline violation involving the use of a student's vehicle (examples may include cutting class or leaving school without permission) will cause the student to lose the privilege of parking at school.
- 10) Students with excessive tardies (6 per semester) will have parking privileges suspended for ten school days and a student-parent-administrator conference must be held before the privileges are returned. Continual tardies to school may result in parking privileges being revoked for the remainder of the year.
- 11) North Augusta High School is a closed campus and students may not leave campus for lunch. Violations will result in parking privileges being revoked.
- 12) Parking violations will be referred to the appropriate administrator for disciplinary action to include suspension and/or revocation of parking privileges. This disclaimer serves as the only warning for all of these rules. A first violation for parking in an inappropriate location will result in a suspension from parking and school.
- 13) Students found parking in a handicapped parking space will be suspended, have parking privileges revoked for the remainder of the year, and are subject to being issued a citation by the NA Department of Public Safety.
- 14) All violations of this policy are subject to the student's vehicle being towed at the vehicle owner's expense.
- 15) A student must have a driver's license to be eligible to receive parking.
- 16) Students may not park off campus on city streets (ex. Whitebark Ave.) A first violation for parking in an inappropriate location will result in a suspension from parking and school.
- 17) There is to be no loitering in vehicles or in the parking areas. Students are to leave their vehicles and the parking areas at 8:00 AM, and are not to return to them until the school day has ended. Special permission from the office is required for a student to return to the parking area during the school day. All vehicles parked on the school campus are subject to being searched at the discretion of the administration.

Parking on campus is a privilege. When all parking spaces are issued to students, there will be a waiting list for the next available parking space. If parking privileges are revoked, all fees are forfeited.

A student parking on campus without having registered their vehicle will have their vehicle towed at the owner's expense.

A student's discipline and academic record will be considered when assigning parking.
