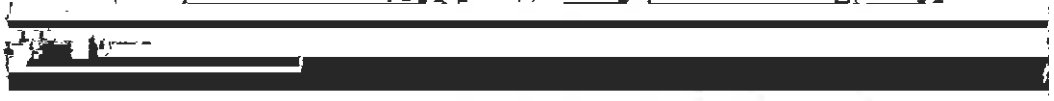

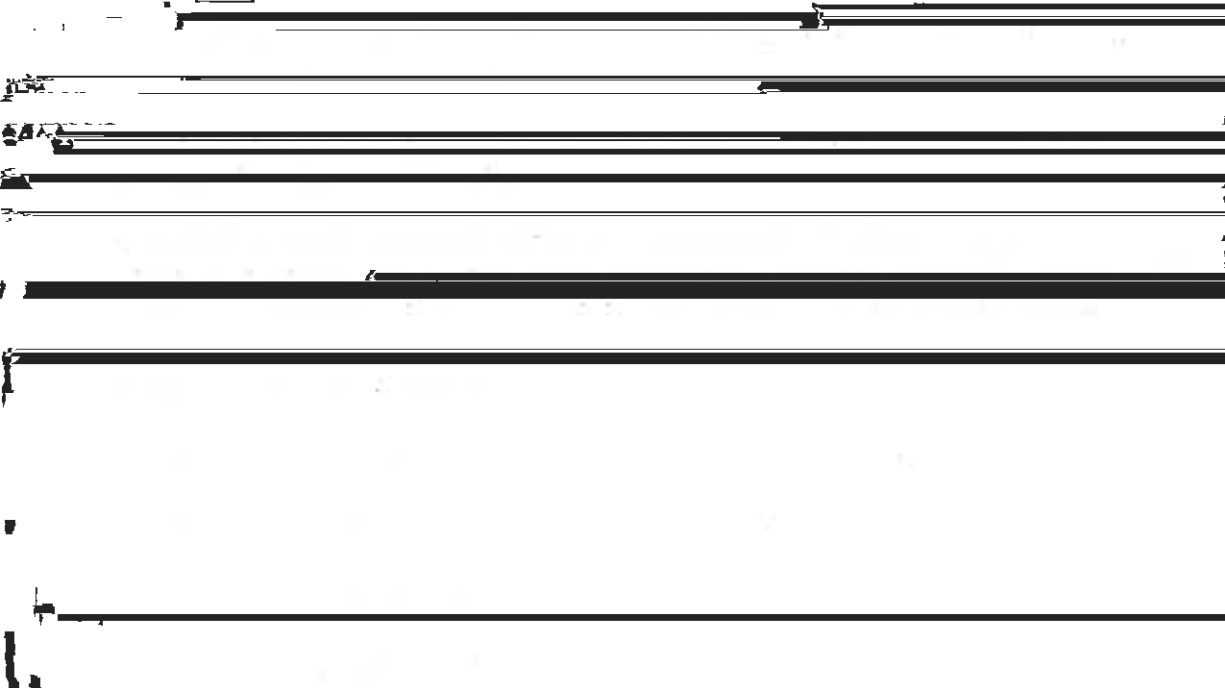
The American Rescue Plan (ARP) was signed into law on March 11, 2021. The SC
